**Approve Agenda** A MOTION WAS MADE BY Trustee Ninmann and seconded by Trustee Robbins to approve the agenda. All Members – aye - motion carried.

### ENGINEERING/ATTORNEY/FINANCIAL ADVISOR

**PUBLIC INPUT** – Todd Toman mentioned the old 1860s historic train that came thru Fall River. It started from Canada and is traveling to northern Mexico.

#### **PUBLIC WORKS**

Change Speed Limit & Sign Locations on North Main Street – There is a speed limit sign on North Main Street that needs to be moved so a sidewalk can be poured to close the gap that currently exists. There will be a total of 14 driveways along that side of North Main after all the condo units are built. We will need to involve the County if we make this change. A MOTION WAS MADE BY Trustee Ninmann and seconded by Trustee Dykstra to proceed with changing the speed limit from 25 to 35 and change location of the sign to the Village limits. All Members – aye - motion carried.

A resident on Sleepy Hollow contacted Julius regarding large cottonwood trees that he feels should be taken down. Julius agrees with him. He believes they are in the ROW and it is the Village's responsibility to take them down. If that is the case, Julius should get an estimate from Steinhorst to take them down.

The park bathrooms are open. There are issues in each one with the water heaters. A tankless water heater has been put in Brayton Park.

Julius asked Chief Spurbeck if the PD could watch the park restrooms periodically. There has been vandalism already. Chief Spurbeck said they will lock them at night if the DPW will unlock them in the morning.

Jason has been doing a really good job. The Scag mower has been a pain with needed minor repairs and parts. The FR School has the sign for Brayton Park almost done. The cost is \$360.00. All we need to do is drill a couple holes and hang it up. Lift stations are scheduled to be cleaned on the 29<sup>th</sup>. Julius is patiently waiting for Jeff Schultz to start in June.
